Thank you for your recent enquiry. We would love to support your child to develop optimal communication skills!

Please find below the estimated costs for speech-language therapy in 2025.

Each medical aid pays different rates. Below you will find the **Discovery Health rate** for consultations. Your medical aid's rate might vary with approximately R 10.00 (more or less) if you are not on Discovery Health. The **private rate** is the same as the Discovery Health rate.

1. Diagnostic Speech-Language Assessment:

The first consultation is an hour session and comprises an intake interview and direct assessment.

First consultation (60 minutes) – diagnostic assessment, including assessment	R 1 490.20
Annual Administration Fee (once off annually)	R200
Follow-up assessment sessions (if required) are billed according to the time spent with the client (older children)	R 319.30 / per 30 minutes*
Re-assessment report	R 745.10
Progress report	R 319.30

2. Speech-Language Therapy:

Following the diagnostic assessment, therapy commences and usually takes place once a week.

16 - 30 minutes	R 319.30
31 - 45 minutes	R 532.10
46 - 60 minutes	R 745.10
Home Programme (optional)	R 745.10*

Please Note:

1. The practice charges **medical aid rates**, as prescribed by the Board of Healthcare Funders (BHF) of Southern Africa.
2. Should your medical aid cover speech therapy sessions, the practice will claim directly from your medical aid. It is your personal responsibility to advise the practice of any special conditions to be complied with before the account is submitted to the Medical Aid.
3. If speech therapy sessions are not covered by your medical aid, payment of the full account is your personal responsibility.
4. All accounts must please be settled within **30 days** from receiving the account.
